LAURENTIAN UNIVERSITY
RESEARCH EXCELLENCE AWARD 2019-2020

Eligibility

To recognize outstanding research performance, Laurentian University established a **Research Excellence Award**. Full-time faculty members may be nominated for the Award if they:

- ◆ have been successful in one or several areas of research in the past five calendar years;
- ◆ are judged to be "outstanding", rather than merely "very good";
- ◆ appear to have contributed to the advancement of knowledge in an original and creative way;
- ◆ are perceived as having enhanced through their research, the prestige and reputation of Laurentian University;
- ◆ have a profile that includes regular teaching and administrative duties.
- ◆ Please note that Research Chairs are ineligible for this award.

Criteria

Although members of the Selection Committee are free to weigh different aspects of research and different sources of evidence, preference is given to the following criteria:

- ◆ completed and published work during their research career **with emphasis on the last five years**;
- ◆ quality and originality of the contribution, whether it is in the applied, artistic, professional, scientific, or other area of academic endeavour;
- ◆ external research grants and/or contract research administered by Laurentian University inasmuch as external funding is appropriate to the discipline or the study area;
- ◆ recognition by the national or international academic community;
- ◆ success in creating a research environment or in strongly advancing Laurentian University's research reputation.

Selection Committee

The Office of the Vice-President, Research will call for nominations at large to serve on the Selection Committee. The Selection Committee will have one representative from each faculty and the Library. The Director of the Office of Research Services will serve as voting Chair. The mandates of the elected members will be for a 2-year period with 50% being elected each year.

Procedures

- ◆ Nominations will be accepted either from a Dean, the University Librarian, a Chair/Director, or three colleagues from any department. Self-nominations will not be accepted.
- ◆ Although no standard form of submission is required, a suggested outline is included. It is the Sponsors' responsibility to provide *sufficient evidence* from as many sources as possible, to make it clear that *outstanding work* deserving of recognition has been done.
- ◆ ***Evidence of outstanding performance must include an updated resume, a list of published works in the last two years. Other evidence that could be submitted includes the following: proof of external research funding awards and/or other prize-winning awards, testimonial letters of recognition (including being asked to sit on national or international adjudication committees, endorsements from peers, alumni, or administrators) and any other relevant information. LAURENTIAN UNIVERSITY
RESEARCH EXCELLENCE AWARD 2019-2020

- ◆ The Award will be bestowed only when *evidence of outstanding performance* is found.
- ◆ Letters of nomination with full supporting documentation should be sent to the Office of the Vice-President, Research, **by 4:00 p.m., Friday, November 1, 2019. *The dossier must be complete.***
- ◆ The successful candidate will be honoured at the Spring Convocation.
- ◆ The winner will become eligible again for the Award only after her/his sabbatical has been completed.
- ◆ The Selection Committee may use external reviewers for advice.

Award

The award will be in the form of a stipend of \$15,000. This stipend can be deferred until the recipient is on sabbatical and can either be added to the recipient's salary or paid as a sabbatical research grant (provided the proper forms and approval are obtained).
